



Airport Charges Regulation

Summary

Definitions

Chapter 2 aircraft

All aircraft noise certificated as published in Annex 16, volume 1, part 2, chapter 2

Noisy Chapter 3 aircraft

Chapter 3 aircraft whose sum of the certification noise levels differs less than 5 EPNdB with the chapter 3 limits as published in Annex 16, volume 1, part 2, chapter 3.

Other Chapter 3 aircraft

All chapter 3 aircrafts that do not fall under noisy Chapter 3 aircrafts.

Chapter 14

A civil subsonic aircraft certified to the standards referred to in Annex 16, volume 1, Chapter 14, to the ICAO convention (eighth edition, July 2017). As well as any Chapter 3 or Chapter 4 aircraft where the difference between the three EPNdB limit values and the three EPNdB certification values is at least 17dB.

General Aviation

General aviation in the context of slot coordination at Rotterdam The Hague Airport is defined as flights, not forming series of flights, operated by aircraft designed for passenger transport of less than 20 persons and with a maximum take off weight up to and including 45.000 kg.

Landing

Any approach of the runway including touch and goes, low passes and missed approaches.

Start and Landing charges

The amount to be charged for an aircraft landing is determined by the following factors

- The aircraft's mass (MTOM)
- The noise certification of the aircraft
- The time of arrival and subsequent departure at Rotterdam The Hague Airport
- Average of the number of passengers on board, of the landing and subsequent departure

Local ATC Levy

Local ATC levy will be charged via the en-route ATC charges.

Passenger charge

The passenger charge applies for all departing passengers on flights operated by aircraft with a maximum take-off mass (MTOM) that exceeds 2.000kg. The charge includes a € 1,22 fee on behalf of the EU-regulation 'Passenger Reduced Mobility'.

Parking charge

Parking charge is dependent on the aircraft's mass (MTOM). The parking charge is charged per 24 hours. No parking charge is due if a parking takes place for a period of less than 6 hours.

Security surcharge

The security surcharge applies for all departing passengers on commercial or international flights.

Turnover taxes

All charges listed are exclusive of any taxes or levies payable thereon.

Noise fee

The fee will be calculated over the landing & take-off fee and applicable for jet aircraft.

NOTE: Chapter 2 and noisy Chapter 3 operations are only allowed between 8.00 lt. and 18.00 lt. or allowed between 7.00 lt. and 23.00 lt. for business jets only.

Load factor fee

Paragraph 1

The fee will be calculated over the landing & take-off fee, applicable for aircraft with a mass above 4.000 kg. Calculated by number of passengers on board divided by the number of seats on board.

Winter season

Notwithstanding paragraph 1, an aircraft over 4,000 kg with fewer than 20 seats on board will be charged a surcharge of 140% on the take-off or landing during the summer season. During the winter season the surcharge is 130% on take-off or landing.

Fee related to time of the day

The fee will be calculated over the landing & take-off fee, applicable for aircraft with a mass above 20.000 kg.

Rotterdam The Hague Airport is a fully (level 3) slot coordinated airport for commercial aviation. All flights are required to obtain a slot prior to arrival at Airport Coordination Netherlands by sending an email to scr@slotcoordination.nl (commercial flights in IATA SCR format, other (GA/BA) flights in IATA GCR format) to gcr@slotcoordination.nl. Slots for General Aviation are implicitly allocated when the operator sends the required handling request.

Handling is required for all visiting aircraft
